JANUARY 24 th	Issue Election Order and Post Notice of Election on Bulletin Board.
JANUARY 24 th	Post Notice of Draw for order of Names on Ballot
FEBRUARY 12 th	First day for filing application for place on ballot.
MARCH 14 th	Last day for filing application for place on ballot (must be received by 5:00 p.m.)
MARCH 15 th	First day to accept applications for voting by mail.
MARCH 22 nd	Draw for order of names on ballot at 9:00 a.m.
MARCH 30 th	First day to mail early ballots.
APRIL 14 th	Publish Notice of Election.
May 2 nd	First day of early voting by personal appearance. (Extended hours: 8:00 p.m. Thursday, May 5, 2011 and Tuesday, May 10, 2011. Saturday voting: Saturday May 7, 2011)
MAY 6 TH	Last day to receive application to vote by mail.
MAY 10 th	Last day for early voting by personal appearance.
MAY 13 th	Notice of City Council Meeting to canvas the returns (posted at least 72 hours before time of meeting) .
MAY 14 th	Election Day polls open 7:00 a.m. to 7:00 p.m. First Baptist Church Fellowship Hall
MAY 17 th – 25 th	Periods for official canvas; Mayor sets exact day and hour.
