RULES & REGULATIONS GOVERNING
GARAGE SALES

(General Ord. 5.04.001 – 5.04.006, 9A.44.6.L)

1. Any individual or group intending to conduct a “garage sale” must register at with the **City of Kaufman** located at **209 South Washington, Kaufman, Texas**.
2. The names of all persons participating in the sale, including consignment sellers, and those conducting the sale or associated therewith must be submitted and listed on the registration form.
3. Any group or individual is limited to three (3) such sales during a twelve (12) month period; each sale is limited to only three (3) consecutive days.
4. Garage sale signs shall not be erected earlier than noon, the Thursday before the sale and shall be removed no later than 6:00 p.m. the Sunday following the sale.
5. PROHIBITED SIGNS (These signs are NOT ALLOWED and will be removed):
 - **NO** Box signs (signs attached to boxes and weighted to prevent blowing)
 - **NO** Signs attached to utility poles, telephone poles or public sign poles.
 - **NO** Signs that are larger than two (2) square feet (1’ x 2’)
 - **NO** Signs in the **RIGHT-OF-WAY** (between the street and the sidewalk and/or between the backside of the telephone poles and the paved edge of the road)
 - **NO** Signs within ten (10’) feet of the paved edge of a public roadway
 - **NO** Signs placed on private property without the written consent of the owner.
 - **NO** More than one sign on the property where the sale is taking place.
 - **NO** Signs erected outside of the allotted time period.
6. No goods shall be sold, and no sales shall be conducted on the City Streets, County, or State Highways, or any right-of-way.
7. Individuals or groups registering with the City of Kaufman for such a sale may be denied, if previously found guilty of a violation regulating garage sales under this ordinance.
8. Person(s) issued a citation, for any non-conforming sale, have a maximum of two (2) hours for compliance. Failure to comply after that time shall result in the issuance of an additional citation and fees.

*** The 3rd garage sale, within 12 months, will require you to provide a sales tax ID number before a permit can be issued.**

NOTE: These requirements do not apply to charitable or non-profit organizations. Please request a Temporary Use Permit from Development Services.
